What is the purpose of this update?

This document tells you how the Koura Wealth KiwiSaver New Zealand Fixed Interest Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The Fund provides an exposure to New Zealand Government and Corporate bonds. The Fund will invest in underlying funds which provide exposure to New Zealand Government and Corporate Bonds or underlying securities, which will be managed directly by Koura Wealth with the assistance of Koura's strategic partner Hobson Wealth Partners. The Fund expects to deliver a negative return once in every 7-9 years.

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Lily had \$10,000 in the fund at its inception (23 October 2019) and did not make any further contributions. At the end of the period (31 December 2019), Lily incurred a loss after fund charges were deducted of \$109 (That is 1.09% of her initial \$10,000). Lily also paid \$5 in other charges. This gives Lily a total loss after tax of \$114 for the period.
