## Snapshot case study

A large Australian state government department engaged Certus to implement an information governance framework – tools, processes and roles – to manage incoming data.

We faced some unique challenges that required modifications to traditional definitions of information governance roles. The department was unable to assign the “data steward” task to individuals. We created an ownership structure based on data steward groups for subject domains. Individuals rolled in and out of stewardship roles as they joined governance groups.

The IBM Business Glossary was deployed. Initially only 200 terms were entered and assigned to a small number of steward groups. Since then the glossary has grown to over 4000 terms across multiple domains and can be accessed by 3500 staff.
