

TASCO 'Inspired Kitchen' Contest Official Rules

- 1. Eligibility:** Contest is open to all legal residents of Ontario who are 18 years of age or older as of February 1, 2020. Employees, officers and directors of TASCO Appliances (the 'Sponsor'), their parents, affiliates, subsidiaries, agents, advertising and promotion agencies, their immediate family members (parents, children, siblings, spouses) and persons living in the same household (whether related or not), are not eligible to participate in the Contest. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Contest will open on February 1, 2020 at 12:01am EST and end at 11:59pm EST on April 12th, 2020 ("Contest Period"). Void where prohibited.
