### Terms and Conditions

#### 1. General

The following terms and conditions will apply to this Competition.

By entering the Promotion you acknowledge that you have read and agree to be bound by these terms and conditions.

This Promotion may have been promoted on Facebook and you acknowledge that the promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook and you agree to release Facebook from any liability associated with the Promotion.

#### 2. Definitions: in these Terms and Conditions–

“**Competition**” means the Harcourts Western Australia Appraisal Competition undertaken during the Competition Period.

“**Competition Period**” is from 13<sup>th</sup> January 2020 until 1<sup>st</sup> March 2020 (inclusive).

“**Harcourts WA**” means Harcourts WA Pty Limited.

“**Participating Office**” means a Western Australia Harcourts office operated by a franchisee listed at Schedule 1 of these Terms and Conditions.

“**Owner**” means the persons on the title of the property being appraised.

References to **dollars** are Australian Dollars.

Harcourts WA reserves its right to cancel or amend this Competition and these Terms and Conditions without notice including in the event of a catastrophe, war, civil or military disturbance, natural disaster or any actual or anticipated breach of any applicable law or regulation or any other event outside of a Participating Office's control.
