RE: Coronavirus Update #5

On March 11, 2020 Governor Ron DeSantis issued an Emergency Order relative to visitation in Florida's nursing homes and other regulated facilities. For us, applicability includes our Skilled Nursing Facility and our Assisted Living Facility (regulated facilities). However, as you know, having a safe and healthy environment for all is our greatest concern. As such, some of the Governor's mandates will be applied to our entire campus. This decision was made with great thoughtfulness and consideration as to how this may impact each of you and your families/friends.

The below represents measures being implemented to mitigate the risk to our residents:

- Many large group events will be cancelled or postponed. Please know that we will provide as much advanced notice as possible of such cancellations or postponements.
- Community events that are held will only be open to our residents.
- Regarding international or cruise travel:
 - For residents, please self-isolate for 14 days upon your return home from international travel or a cruise. Please notify Gail Chase and Cynthia Deveaux at Sarasota Bay Club (941.366.7667) and Linda Wiley or Martha Pimental at Jacaranda Trace (941.408.2000) should this apply to you.
 - For family members and visitors, we ask they do not visit our community for 14 days after international travel or a cruise. Please notify your family as applicable.
 - We have added a section to our websites that includes all our Coronavirus memos to date and our current protocols. Please direct

- If you have a loved one living at The Inn or Cadbury Park the Governor **has issued a prohibition** on visitors that have *travelled on a cruise ship* until 14 days after their return to the United States. The Governor has also issued a prohibition on any person who has *travelled internationally* from visiting any skilled nursing or assisted living until 14 days after their return to the United States. We will be enforcing this Emergency Order. Please notify your family members as appropriate.
- We continue to welcome visitors into our community; however, the following individuals must not visit our community:
 - Any person infected with COVID-19 who had not had two consecutive negative test results separated by 24 hours should not visit our community;
 - Any person showing or presenting signs or symptoms of a respiratory infection, including fever, cough, shortness of breath, or a sore throat should not visit our community;



- Any person who has been in close contact with a person(s) infected with COVID-19 who has not tested negative for COVID-19 should not visit our community;
- Any person who has been in a community with confirmed community spread of COVID-19, *as identified by the CDC or a state public health agency*, should not visit our community; and
- Any person who resides in a community with confirmed community spread of COVID-19, *as identified by the CDC or a state public health agency*, should not visit our community.

We understand that some of these measures may present challenges for you, but please understand that we are making decisions based on concern for our resident's health in conjunction with guidelines presented from our local health officials/government agencies. With the above protocols in place, we are aligning with the current governmental mandates provided.
