## Auto-Debit Authorization Form & Payment Plan Agreement

By completing the information requested below, you (the member) agree to pay your annual dues in full, and to spread the payments over one year, and you authorize the Pacific Southwest Association of REALTORS® (PSAR) to automatically charge your credit card monthly for payments based on information you will provide in the form below. Monthly payments are made from June through May of each cycle. Each monthly payment will be allocated in a manner determined by PSAR. Auto-debits will be processed on the last business day of the preceding month following receipt by PSAR of your completed authorization form. Members who sign up after June of any cycle agree that missed payments will be charged at the same time as the first auto-debit. By signing this agreement you agree to all of the terms of this Payment Plan. This agreement and the payment authorization will automatically renew on June 30 of each year until terminated in writing by notice delivered by either party to the other. By May 30 of each year, that year's dues are paid in full. The dues and fees charged by PSAR are subject to change. Notice of increases in dues and fees will be provided with thirty days notice via email. During the thirty days prior to an increase, members will be offered the opportunity to discontinue participation in the monthly payment plan. **INITIAL** \_\_\_\_\_

To stay active on monthly payment plan, a valid credit card **must be** kept on file. If monthly payments are denied by the member's credit card company, membership will be terminated and a reinstatement fee of \$30 will be applied to reinstate your membership under a payment plan acceptable to PSAR in its discretion. All payments are non-refundable. **In addition, if a member cancels service or terminates service after December 31 and before June 30, an early termination fee of \$200 will be due and payment will be due and payable to PSAR.** This plan is only offered to REALTORS® who are also MLS subscribers or participants and hold a lockbox key card. **INITIAL** \_\_\_\_\_
