Financial Close Management

The Financial Close Management suite consists of three modules: Close Manager, Account Reconciliation Manager, and Supplemental Data Manager.

Close Manager

Close Manager is a task management solution. Tasks can be anything related to the close process - whether in the transaction system, general ledger, consolidation system or reporting system. Employees are assigned to each task and the tasks are given a due date relative to each period end date, so it's also easy to identify bottle-necks in the process.
