

1) Quorum requirements-

Because the Stapleton MCA has not received the amount of votes to have a quorum at the 1st and 2nd meeting, the Executive director has proposed an amendment to article 3.7. If the text of the article is changed it will allow the annual elections to run smoother, with less expense to the residents (i.e mailers). The new text for article 3.7 will read as follows;

Section 3.7 Except as may be otherwise provide in the Community Declaration, the Articles of Incorporation or these Bylaws, and except as hereinafter provided with respect to the calling of another meeting, the presence, in person or by proxy, of Members entitled to cast at least five percent (5%) of the votes of all Members in any Delegate District shall constitute a quorum at any meeting of such Delegate District. Members present in person or by proxy at a duly organized meeting may continue to transaction business until adjournment, notwithstanding the withdrawal of Members so as to have less than a quorum. If the required



quorum is not present in person or by proxy at any such meeting of Members within the Delegate District, another meeting may be called, subject to the notice requirements hereinabove specified, and at such meeting the quorum shall be a majority of the number of Members present in person or by proxy at such meeting
