DORA Licensing

- Must have one licensed manager at the organization. The Executive Director is taking the steps to become licensed.
- The process takes about a year, requires background check and fingerprinting.
- 24 hour training and test, which has been completed. Final state test will be completed by July 1, 2015.

Section 7.6 Violations

- Section 7.6 is in the MCA's CCR's which is the master governing documents. This section includes maintaining property (maintenance of lawns, trees, etc).
- The MCA responds to complaints when received, by inspecting the property, issuing letters and charging fines.
