At numerous meetings over the past several months, the available time for public comment has not been able to accommodate the number of persons wishing to speck about the community name. - For Sale Affordable will be \$25/month beginning in January
- Filing 2 Commercial, Office, Other will be \$14.00 per 2,000 s.f./month
- 'For Rent' Affordable product will remain \$12.00 per month in 2018
- The MCA currently manages 200 acres of green spaces which is up substantially comparatively to 2017
