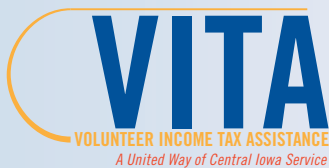


VOLUNTEER INCOME TAX ASSISTANCE

If you earned \$58,000 or less in 2016, you may be eligible to receive FREE tax preparation. You also may be eligible for the Earned Income Tax Credit (EITC) or Child Care Tax Credits. This is your money to keep and save.

Call 2-1-1 for more information. 2-1-1 is free and available 24/7.

IMPORTANT! United Way must have a copy of last year's tax returns or a tax return transcript to prepare your taxes. We will not have access to last year's return information. To request your transcript, go to www.IRS.gov and under "Tools," click on "Get a tax transcript." After answering the questions, you can print your transcript. Or you can call 1-800-908-9946 and follow the prompts. Call 2-1-1 with questions.



FREE TAX PREPARATION.

DO I QUALIFY? You may qualify if you made \$58,000 or less in 2016.

WHAT TO BRING

- Proof of identification
- Social Security cards for you, your spouse, and dependents and/or a Social Security number verification letter issued by the Social Security Administration
- Birth dates for you, your spouse, and dependents on the tax return
- Current year's tax package if you received one
- Wage and earning statement(s): Form W-2, W-2G, 1099-R from all employers
- Interest and dividend statements from banks (Forms 1099)
- A copy of last year's federal and state returns
- Bank routing numbers and account numbers for direct deposit. Blank check or deposit slip required.
- Total paid for child care provider and the child care provider's tax identifying number (the provider's Social Security number or the provider's business Employer Identification Number)
- To file taxes electronically on a married-filing-joint tax return, both spouses must be present to sign the required forms.

REFUND

If you made \$58,000 or less, you may be eligible for:

- **\$6,318:** Maximum amount with three or more qualifying children
- **\$5,616:** Maximum amount with two qualifying children
- **\$3,400:** Maximum amount with one qualifying child
- **\$510:** Maximum amount with no children
- Investment income must be \$3,450 or less for the year.
