

CALIFORNIA PROPOSITION 65

NOTICE TO ALL DISTRIBUTORS AND MANUFACTURERS SELLING ODL PRODUCTS TO CALIFORNIA CUSTOMERS

October 14, 2019

Dear Valued Customer,

All Distributors and Manufacturers selling ODL products (either as "stand alone" products, or used in manufacturing doors and windows) need to comply with California's Proposition 65 warning requirements. These warning requirements apply to the products listed in the attachment (page 2), because these ODL products may result in an exposure to one or more Proposition 65 listed chemicals.

To comply with these requirements, you need to do the following:

- 1. You must provide a Proposition 65 warning to your retail customers in California.
- 2. If you sell your products through distributors, you must inform your distributors of their duty to provide Proposition 65 warnings to their retail customers in California.
- The attachment on page 2 provides you with the necessary warning materials you should include in your packaging labels, display signs, and on any internet or catalog sales pages for these products.

Compliance with Proposition 65 warning requirements is very important, and there may be significant regulatory and legal penalties resulting from the failure to meet these requirements. Although we can't give legal advice about Proposition 65 issues, we are available to help you work through any compliance questions you may have.
