THERE ARE MANY US SANCTIONS LISTS



US Sanctions Lists

- Asset Freezing Lists:
 - Specially-Designated Nationals (SDN), Executive Order 13599 List
 Some listings have secondary sanctions attached
- Consolidated Sanctions List 5 sublists
 - Includes Sectoral Sanctions Identification List (SSI)
- State Department:
 - Cuba Restricted List, CAATSA Part 231 List

Even if no regulatory issues, there are customer satisfaction issues

THE OFAC AND EU 50 PERCENT RULES



OFAC 50 Percent Rule

- Combined ownership by sanctioned parties >= 50% makes company sanctioned
- For names on OFAC's asset freezing lists & the SSI List
- Also state-owned companies of blocked governments
 - Cuba, Iran, North Korea, Syria & Crimea
- OFAC also recommends caution for large stakes < 50%



EU 50 Percent Rule

- Majority ownership by a single sanctioned party > 50% makes company sanctioned
- For all EU sanctions programs

SANCTIONS OWNERSHIP RESEARCH



Sanctions Ownership Research

- Companies with 10% or more ownership by sanctioned subjects
- State-owned companies of blocked governments
- Companies with sanctioned party in senior management or on board of directors
- Includes 2 levels of subsidiaries



Sanctions Ownership Research

- For all OFAC and EU sanctions programs
- Denotes if majority threshold is reached
- Notes contains details of owners and percentages
 - Prior ownership stakes as well
