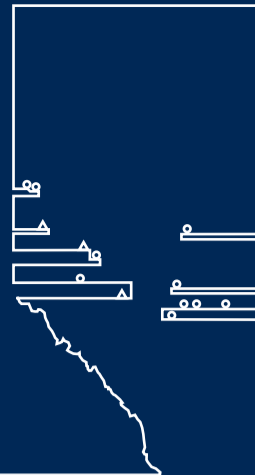


SECURE AT A GLANCE

2017 Highlights

GROWTH



Acquired 10 water disposal facilities and expanded three landfills in Alberta to better support our customers.



Acquired the Canadian division of a production chemical business growing our existing business line. The purchase included 100 proprietary products, a 13,000 square feet laboratory and a 48,500 square feet blending facility.



Began construction on a light oil pipeline to transport Canadian oil to major markets.



Increased the container rental fleet by 13 percent in 2017 vs. 2016.



Growing our people from within included 172 promotions, 59 transfers and 3,300 training hours.



Completed fabrication of eight additional high volume, high pressure pumps at our Red Deer facility for use in our Integrated Fluid Solutions.

SAFETY



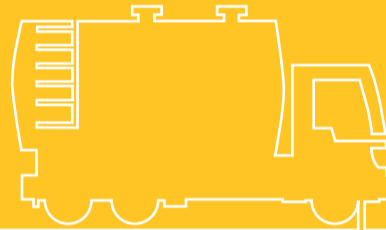
Proactive efforts per employee doubled for the second consecutive year to 67 per employee.



Total Recordable Incident Frequency (TRIF) decreased by 38 percent to 1.07.



Completed the annual Certificate of Recognition (COR) audits and scored well above the mandated requirements in all three of SECURE's divisions.



Avoided trucks on the road traveling over 10,000,000 kilometres by using SECURE's Integrated Fluid Solutions.

Calgary-based employees raised over \$10,000 for seven Adopt-a-Families over the holiday season.

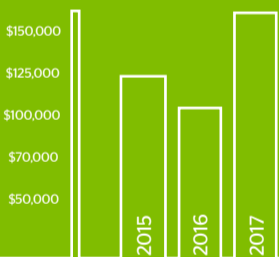


Over \$200,000 was invested back into the local communities where we live and operate across Western Canada and North Dakota.

FINANCE

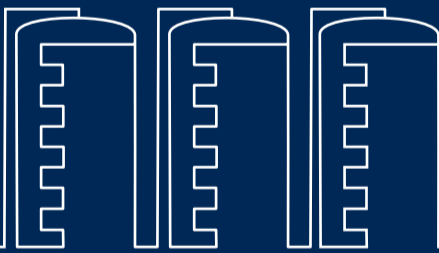


Increased adjusted EBITDA by 67 percent from 2016 to 2017. Drilling activity levels combined with SECURE's dedication to delivering customer-driven solutions resulted in adjusted EBITDA of \$157.2 million.



Achieved consolidated revenues of \$603 million (excluding oil purchase and resale) in 2017.

DISPOSAL



Responsibly handled over 14 million cubic metres of oilfield fluids - equivalent to almost 6,000 Olympic-sized swimming pools.

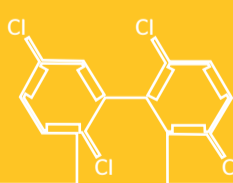


Received and safely contained 1.7 million tonnes of oilfield solids into our engineered Landfills.

ONSITE



Became ISO 14001 certified for pipeline construction, maintenance and repair that will govern all SECURE's pipeline activities.



Safely removed and disposed of 20,000 tonnes of PCB contaminants at a former compressor station.



Used risk assessment to divert about 30,000 cubic metres of soil from landfill disposal.

PARTNER



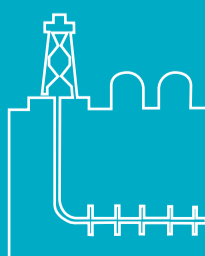
Recycled 13,227,000 kilograms of steel - equivalent to the weight of the Brooklyn Bridge.



Reclaimed approximately 2.5 million square meters of land - equivalent to two times the area of Calgary's downtown.



Partnered with the British Columbia Oil and Gas Commission, University of British Columbia Okanagan and Mitacs acceleration program to study the water life cycle for hydraulic fracturing operations.



Provided input to the finalization of the Alberta Water Policy document created to reduce freshwater used for hydraulic fracturing.
