Key Components

Identify Critical Behaviours

Gather Data

This information is especially important for the small subset of exposures that have a higher likelihood of leading to serious or fatal injuries. We help you train employee observers to collect information on exposure using your own set of safe work definitions. We also work with your team to develop a sampling strategy that captures data on exposure across departments, activities, and shifts.

Provide Feedback

Workplace observations are only the start of identifying exposure. Dialogue during, after, and outside of observations is essential to understanding what is occurring and why. We work with your team to develop feedback skills and practices that serve as a pathway to open and honest discussions about safety. Through peer-to-peer observation and feedback, employees can provide valuable information about why risks are occurring, how the configuration is working, and what employees are seeing and thinking.
