Emergency Overview: Flammable liquid and vapor.

First Aid - Eye Contact: Flush eye(s) immediately with plenty of water. Rinse with plenty of water.

First Aid - Inhalation: Move to fresh air. Oxygen or artificial respiration if needed.

First Aid - Ingestion: If swallowed seek medical attention. Never give anything by mouth to an unconscious person. Call a physician or Poison Control Center immediately. Do not induce vomiting without medical advice.
