## **DESCRIPTION**

**DIGEST PLUS** is an exciting new product that is composed of specially bred enzyme/bacterial cultures that actually attack and break down the uric acid molecules. ## **DIRECTIONS FOR USE**

### **TILE, GROUT, URINALS, AND OTHER HARD SURFACES:**

1. The area should first be cleaned of excess material. If the area is not moist, use lukewarm water on the surface to be treated with **DIGEST PLUS**.  
2. Insert a trigger sprayer into the bottle and you have a ready-to-use product which will eliminate the odors produced from the organic material and decomposed salts associated with urine. Spray on area to be treated and allow to air dry. **DIGEST PLUS** can also be used as a mop on application for restroom floors. Apply to floor and allow to air dry.

### **CARPET AND UPHOLSTERY:**

1. Remove surface soils, excess waste, and protein contaminants with plain lukewarm water or with a mild neutral detergent.  
2. Spray or wipe on problem area until moist.  
3. Keep the carpet or upholstered item moist for at least 4 hours. (6-12 hours in extreme cases).  
4. In severe cases you may have to treat carpet pad and flooring separately with **DIGEST PLUS**.

This product has met the DuPont test for use on "New Generation" carpet. **DIGEST PLUS** does not affect the stain resistant properties.
