**eTracks MT & OTR Tire Recovery Fee effective January 1<sup>st</sup>, 2019**

Dear eTracks Producer:

As January 1<sup>st</sup>, 2019 approaches, eTracks would like to provide our customers with more details on the Tire Recovery Fees surrounding the Medium Truck and OTR Tires. eTracks has calculated the 2019 MT & OTR Tire Recovery Fee and has determined that the rates (stated below) are to be remitted by Producers when reporting tire supply to eTracks Tire Management Systems.

These fees for MT & OTR tires will be implemented effective January 1<sup>st</sup>, 2019. Any tires supplied into the Ontario market as of this date must be reported by Producers according to the Tire Categories and recovery fees outlined in the tables below.

**On Road Tires**

On- Road Tires	Passenger and Light Truck Tires (PLT)	1	\$4.00	Includes tires designed for use on passenger cars, light trucks, small RVs and multipurpose passenger vehicles (MPVs), including sport utility vehicles (SUVs) and crossover utility vehicles (CUVs), including temporary spares. Also, includes all tires specifically designed for on/off highway motorcycles, motorcycle sidecars, motor bikes, mopeds, mini-cycles, golf carts.  The Light Truck tire category includes tires designed for use on consumer or commercial light trucks, under 10,000 lbs/4500 kg. Gross Vehicle Weight. Passenger and Light Truck Tires must comply with Motor Vehicle Tire Safety Regulation (MVTSR), Technical Safety Bulletins (TSBs) 109 or 139.
	Medium Truck Tires (MT)	2	\$14.00	Known as Commercial Truck Tires – Truck and Bus tires including Wide Base or Heavy Truck tires designed for truck/bus applications and Larger RV tires not marked "P or LT". All of which comply with Motor Vehicle Tire Safety Regulation (MVTSR), Technical Safety Bulletin (TSB) 119.
