Franklin Control Systems warrants equipment manufactured by it and sold through authorized sales channels to be free from defects in materials and workmanship from date of invoice by Franklin Control Systems or its authorized sales channel as follows:

### • 5 Year Warranty:

Magnetic Contactors, Electronic Overloads, and Molded Case Circuit Breakers. Variable frequency drives, Cerus Brand, installed only in variable torque applications, properly sized and installed per Franklin Control Systems instruction and industry standards per give application.

### • 18 Month Warranty:

All other products.

### • Exclusions and Requirements:

Electronic power equipment, including but not limited to Variable Speed Drives, soft starts and all accessories, require input power line protection against line surge, sag and lightning. Proof of installation of these protective devices is required for warranty service. Drive and soft starter warranty excludes normally serviced items, such as variable speed drive cooling fans and capacitors. all power switching productscontactors, breakers, disconnects, and similar products- are warranted within their respective life cycle and power ratings. Usage beyond the specifications for these products is excluded from warranty.

This is the exclusive remedy for any breach of warranty. This warranty shall not apply (a) to equipment not manufactured by Franklin Control Systems, (b) to equipment that has

been repaired or altered by other than Franklin Control Systems so as, in its judgment, to affect the same adversely, or (c) to equipment that has been subjected to negligence, accident, or damage by circumstances beyond Franklin Control Systems' control, or improper installation, operation, maintenance or storage, or to other than normal use or service within rated electrical, environmental and mechanical endurance specifications for equipment.
