The tags communicate with each other autonomously without supervisory control. Data collected by the tags is communicated to the AiRSITA Flow cloud-based software system which analyzes contact information and manages the tags.

How it Works

The tags use a unique feature of Bluetooth Low Energy which detects other BLE devices in the area. When people come within six feet of each other for a period of time, the device makes an audible chirp and a record of the contact is made in the AiRISTA Flow software system. Triggers for tag distances and event durations are configurable.

The software system maintains reports and supports custom workflows for alerts and report generation. Platform analytics provide a view into behavior trends, potential hot spots, and reports at individual, group and department levels. Because location data is not collected, employee privacy is protected.

Tags communicate with the software platform using existing Wi-Fi systems, employees' smart phones, or small gateways provided by AiRISTA Flow. The system can integrate securely with government and databases and third-party applications.


