

SCHOOL PERFORMANCE FACT SHEET

The California Private Postsecondary Education Act (CPPEA) of 2009, effective January 1, 2010, requires under section 94910 of the Act that a school provide information for each program offered in regards to, completion rates, placement rates, licensure exam passage rates, and salary/wage information. The following information is data compiled for the calendar years of January 1, 2013 through December 31, 2014.

- ³ "Graduates" is the number of students who completed the program within 100% of the published program length.
- 4 "Completion Rate (100%)" is the number of Graduates divided by the Number of Students available for Graduation.
- ⁵ "Completion Rate (150%)" is the number of students who completed the program in the reported calendar year with 101-150% of the published program length divided by the Number of Students Available for Graduation in the published program length period.

The Bureau of Labor Statistics reported that the "median annual wages of licensed practical and licensed vocational nurses was \$41,540 in May 2012. The median wage is the wage at which half the workers in an occupation earned more than that amount and half earned less. The lowest 10 percent earned less than \$30,970, and the highest 10 percent earned more than \$57,360."

The California Employment Development Department (2015) reported the hourly mean for LVN's is: \$25.21.
