

Automobile Agreement

It is your desire to enjoy the freedom, convenience and use of an automobile and it is our desire to assist you in the availability of an automobile while you continue to demonstrate maturity and responsibility. Therefore, we will provide an automobile that we own, and you will be subject to the following conditions. **Violation of these conditions will result in the penalties indicated.**

Condition	Penalties
A moving violation or citation (ticket)	<ul style="list-style-type: none"> • Pay the fine • Pay the increased insurance cost that results • Lose use of the car for 4 weeks
Speeding ticket	<ul style="list-style-type: none"> • Same as above, except lose use of car for 5 weeks
Reckless Driving	<ul style="list-style-type: none"> • Pay any costs for ticket, attorney, and court fees • Pay increased insurance costs • Lose the use of the car for 8 weeks
An accident caused by you (no ticket issued)	<ul style="list-style-type: none"> • Pay any costs not covered by insurance • Pay the increased insurance cost
An accident caused by you (a ticket is issued)	<ul style="list-style-type: none"> • Pay any costs not covered by insurance • Pay the increased insurance cost • Lose the use of the car for 1-3 months, depending on the circumstances
Failure to promptly report a ticket or accident to us	<ul style="list-style-type: none"> • Lose the use of the car for 4 months
Driving under the influence or second reckless driving offense	<ul style="list-style-type: none"> • Pay any costs for ticket, attorney, and court • Pay increased insurance costs • Lose the use of the car until age 19
Failure to maintain a _____ GPA	<ul style="list-style-type: none"> • May only use the car to go to and from school, during school hours
Failure to maintain attitude of cooperation, respect and responsibility at home, school, and at all other times	<ul style="list-style-type: none"> • May only use the car to go to and from school, during school hours

Condition	Penalties
The car may not be taken out of County without prior permission from us	<ul style="list-style-type: none"> • Failure to comply results in the loss of the use of the car for 1 month
You, as a driver, and the automobile have a curfew of _____ or earlier if directed by us	<ul style="list-style-type: none"> • Failure to comply results in the loss of the use of the car for 1 month
No one else will drive the automobile. If someone does, you accept responsibility for their conduct	<ul style="list-style-type: none"> • The same penalties apply as if you had been the driver
Once you have your “permanent” license, you are limited to taking 1 passenger in the car in addition to yourself	<ul style="list-style-type: none"> • Failure to comply results in the loss of the car for 1 month
Flagrant violation of these conditions, such as not fulfilling the requirements of the penalties	<ul style="list-style-type: none"> • All use of the vehicle will be revoked and the care may or may not be sold

The use of an automobile is a privilege that carries enormous responsibilities for you and potential liabilities for us. It is not entered into lightly, but very seriously. We may add further conditions or clarifications as the need arises.
