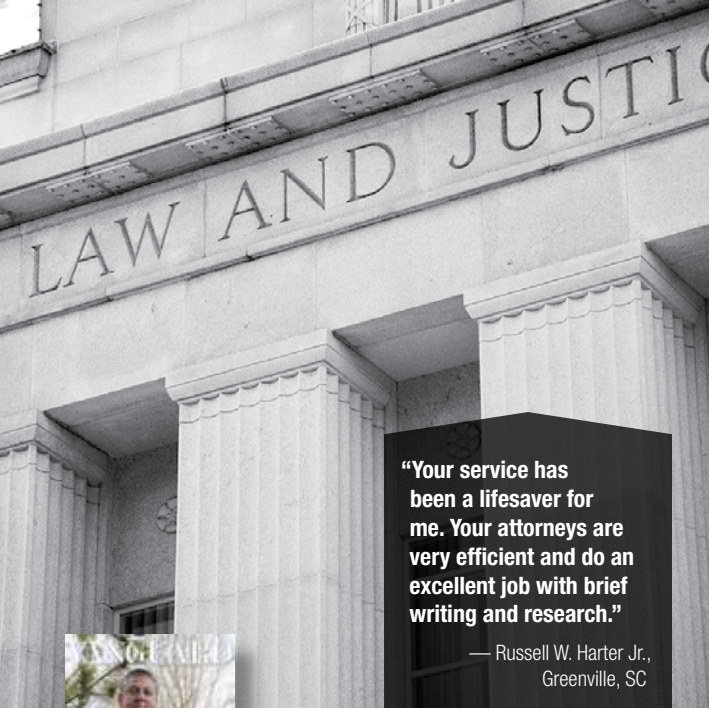

NLRG Client Obtains \$1 Million Settlement in Fetal Death Claim

As reported in *Lawyers Weekly*, John Zydron reached out to the National Legal Research Group in Charlottesville to inquire if his client had a right of action for wrongful death on behalf of Henry, the plaintiff's unborn child who died in a car crash. NLRG's research showed that Virginia case law had held that a fetus is not a legally cognizable "person" separate from its mother until birth, and therefore Virginia's wrongful death statute did not allow a cause of action for the death of an unborn child. But in 2012, the General Assembly amended the Virginia Code, creating a new cause of action for the wrongful death of a fetus. Zydron pressed forward with the claim, and, in a case of apparent first impression under the amended statute, he obtained a \$1 million settlement. Sarah Stanley, Man settles claim for fetal death, *Va. Law. Wkly.*, September 14, 2015 (reporting settlement in *Acree v. Austin*, [15-T-114]).
