No report. However a Branch Development Day meeting has been called for members to attend at IQ HQ on 25.05.2016 with a webinar being available outlining the reason for the meeting. As soon as feedback is available this will be forwarded to L&HC committee members in lieu of a Council Report.

#### **7** Financial Report

A copy of the Branch accounts was produced by Treasurer and presented by the Secretary in his absence for the year ended 31 December 2015. A copy of the Branch Accounts is available by request to the Secretary for those Committee Members who were unable to attend the meeting. The accounts for 2015 were audited by M Benson/M Carter on 11.04.2016.

#### In summary:

Technical evenings finished the year of 2015 as a negative of £140.00 Interest on National Savings was £88.27 Sundry expenses for the year ended 2015 were zero.

This gives a final loss for the year ended 31 December 2015 of £51.73

M Benson has agreed to carry on the role of Honorary Treasurer.

#### 8 Election of Officers

Glyn Richards stood down as Hon Chairman and the members of the L&HC Branch thank him for his endeavours over the past three years. Iain Ormrod was elected as Honorary Chairman with Sharon Spain elected as Deputy Hon Chairman (proposed Mary Carter, seconded Tyrone Partridge).

Mary Carter continues as Honorary Secretary and Honorary Auditor.

Mike Benson remains as Hon Treasurer.

Tyrone Partridge continues as Branch Representative to Council.

Matthew Paul Cross remains as a valued Committee member.

Glyn Richards will remain on the Committee after standing down as Hon Chairman and will take on the role of organising the annual field visit and helping to source speakers for technical meetings.

It was agreed to endeavour to expand the Committee with SS approaching Hope for a volunteer to join the Committee. MC contacted Gary Langton of Brett after the meeting and Will Taylor of Brett was subsequently voted onto the Committee on 22 April 2016.

#### **10** Any Other Business

There still continues to be a lack of support for attendance at Branch meetings hence the decision to keep the meetings to two per annum and look at other avenues of reaching and engaging L&HC Members.
