Terms of Application

- The submitted application must relate to an organisation which wholly or partially supports children or adults with intellectual disabilities. It must be based in South Yorkshire, UK and have been in existence for at least 6 months from the submission date.
- The grant should be used towards activities and equipment that promote the health & wellbeing of your clubs members.
- The organisation must have the appropriate banking mandate in place for the club/society and a relevant bank account associated with a club/society organisation.
- The grant must not be used:
 - For the benefit of an individual.
 - To discriminate or act unlawfully on the basis of gender, race, religion, creed, national origin, disability, age, sexual orientation, or any other basis prohibited by law, as determined by the sole discretion of Xactium.
 - To promote any activities that are unsafe or dangerous, as determined by the sole discretion of Xactium.
 - Towards a raffle, chance or lottery prize or alcohol.
- Xactium reserves the right, in its sole discretion to reject applications that are incomplete, illegible, false or fraudulent, or reject them at any point and for any reason.
- By accepting a grant, you agree that Xactium may publish the name of your club/society and the amount awarded on its website and request approved promotional material.
- By accepting a grant, you agree to providing evidence of how the grant was spent, if requested.
