In the event that it is not possible for you to attend the auction event you may make a proxy (up to a pre-set limit) bid, authorizing a representative of Twin Cities Habitat for Humanity to bid on your behalf. **Please complete and return the Remote Bidding form to the Habitat office no less than two working days prior to the auction** These terms and conditions apply to the Bidder and the Buyer (if different) and you will be bound by them.

TERMS & CONDITIONS FOR REMOTE BIDDING

1. A prospective Buyer should complete and sign this registration form. Failure to complete or sign the registration form will be treated as a fundamental error and that will entitle Habitat to disregard your bid.
2. Habitat reserves the right not to bid on behalf of the prospective Buyer should there be any error or confusion in the registration form or instructions received.
3. The completed form must be delivered to Habitat so that it is received no less than two working days prior to the date of Auction in which the particular property is to be sold.
4. The maximum Proxy bid price must be an exact figure.
5. The prospective Buyer appoints Habitat as an agent and authorizes a Habitat representative to bid for the relevant lot on behalf of the prospective Buyer in such manner as Habitat thinks fit at their absolute discretion.
6. The prospective Buyer shall be considered to have inspected the auction catalogue, the common auction conditions, and separate special conditions of sale, addendum and notices to prospective Buyers for the relevant lot and to have full knowledge thereof.
7. The prospective Buyer should provide one of the following in the form of a deposit with the registration form:
 - a signed blank check drawn on an approved registered financial institution made payable to Twin Cities Habitat for Humanity
 - A valid credit card number with accompanying expiration date and security code.
8. The prospective Buyer may, in writing only, at any time up to the commencement of the auction withdraw Habitat's authority to bid or make alterations to the registration form. It is the prospective Buyer's responsibility to ensure that the Habitat representative personally receives such instructions and the prospective Buyer should check to ensure such instructions have been received.
9. The amount of the prospective Buyer's maximum bid will not be disclosed to the seller or any other person either during or after the sale without the consent of the prospective Buyer.
10. Should the prospective Buyer wish to bid at the auction in person or through an agent, such intention must be conveyed in writing to Habitat in person prior to the lot being offered for sale. In this case Habitat will not make any bids on behalf of the prospective Buyer.
11. Habitat will accept no liability whatsoever for any bid not being made on behalf of the prospective Buyer as a result of: lack of clarity of instructions, error, lack of clarity or confusion regarding the registration form or the deposit or for any other reason whatsoever beyond the control of Habitat.

12. The prospective Buyer will be advised if the relevant lot has been successfully purchased on his behalf as soon as possible after the auction. Payment will not occur on items until Buyer has been notified.

13. Habitat will accept no liability whatsoever for any bid not being made on behalf of the prospective Buyer for any reason whatsoever. Prospective Buyers will not hold Habitat liable for any loss or claims relating to the remote bidding system.
