Represent and solve problems involving multiplication and division.

1. Interpret products of whole numbers, e.g., interpret $5 \times 7$ as the total number of objects in 5 groups of 7 objects each. For example, describe a context in which a total number of objects can be expressed as $5 \times 7$.
2. Interpret whole-number quotients of whole numbers, e.g., interpret $56 \div 8$ as the number of objects in each share when 56 objects are partitioned equally into 8 shares, or as a number of shares when 56 objects are partitioned into equal shares of 8 objects each. For example, describe a context in which a number of shares or a number of groups can be expressed as $56 \div 8$.
3. Use multiplication and division within 100 to solve word problems in situations involving equal groups, arrays, and measurement quantities, e.g., by using drawings and equations with a symbol for the unknown number to represent the problem.
4. Determine the unknown whole number in a multiplication or division equation relating three whole numbers. For example, determine

Understand properties of multiplication and the relationship between multiplication and division.
5. Apply properties of operations as strategies to multiply and divide. ${ }^{2}$ Examples: If $6 \times 4=$ 24 is known, then $4 \times 6=24$ is also known. (Commutative property of multiplication.) continued

$3 \times 5 \times 2$ can be found by $3 \times 5=15$, then $15 \times 2=30$, or by $5 \times 2=10$, then $3 \times 10=$ 30. (Associative property of multiplication.) Knowing that $8 \times 5=40$ and $8 \times 2=16$, one can find $8 \times 7$ as $8 \times(5+2)=(8 \times 5)+(8 \times 2)$ $=40+16=56$. (Distributive property.)
6. Understand division as an unknown-factor problem. For example, find $32 \div 8$ by finding the number that makes 32 when multiplied by 8.

Multiply and divide within 100.
7. Fluently multiply and divide within 100 , using strategies such as the relationship between multiplication and division (e.g., knowing that $8 \times 5=40$, one knows $40 \div 5=8$ ) or properties of operations. By the end of Grade 3 , know from memory all products of two one-digit numbers.

Solve problems involving the four operations, and identify and explain patterns in arithmetic
8. Solve two-step word problems using the four operations. Represent these problems using equations with a letter standing for the unknown quantity. Assess the reasonableness of answers using mental computation and estimation strategies including rounding. ${ }^{3}$
9. Identify arithmetic patterns (including patterns in the addition table or multiplication table), and explain them using properties of operations. For example, observe that 4 times a number is always even, and explain why 4

NUMBER AND OPERATIONS - FRACTIONS

Develop understanding of fractions as numbers.

1. Understand a fraction $1 / b$ as the quantity formed by 1 part when a whole is partitioned into $b$ equal parts; understand a fraction $a / b$ as the quantity formed by a parts of size $1 / b$.
2. Understand a fraction as a number on the number line; represent fractions on a number line diagram.
a. Represent a fraction $1 / b$ on a number line diagram by defining the interval from 0 to 1 as the whole and partitioning it into $b$ equal parts. Recognize that each part has size $1 / b$ and that the endpoint of the part based at O locates the number $1 / b$ on the number line.
b. Represent a fraction $a / b$ on a number line diagram by marking off a lengths $1 / b$ from O. Recognize that the resulting interval has size $a / b$ and that its endpoint locates the number $a / b$ on the number line.

Geometric measurement: recognize perimeter as an attribute of plane figures and distinguish between linear and area measures.
8. Solve real world and mathematical problems involving perimeters of polygons, including finding the perimeter given the side lengths, finding an unknown side length, and exhibiting rectangles with the same perimeter and different areas or with the same area and different perimeters.

Reason with shapes and their attributes.

1. Understand that shapes in different categories (e.g., rhombuses, rectangles, and others) may share attributes (e.g., having four sides), and that the shared attributes can define a larger category (e.g., quadrilaterals). Recognize rhombuses, rectangles, and squares as examples of quadrilaterals, and draw examples of quadrilaterals that do not belong to any of these subcategories.
2. Partition shapes into parts with equal areas. Express the area of each part as a unit

[^2]:    ${ }^{6}$ Excludes compound units such as $\mathrm{cm}^{3}$ and finding the geometric volume of a container.
    ${ }^{7}$ Excludes multiplicative comparison problems (problems involving notions of "times as much").
