For example, create a story context for $(2 / 3) \div(3 / 4)$ and use a visual fraction model to show the quotient; use the relationship between multiplication and division to explain that $(2 / 3) \div(3 / 4)=8 / 9$ because $3 / 4$ of $8 / 9$ is $2 / 3$. (In general, (a/b) $\div(c / d)=a d / b c$.) How much chocolate will each person get if 3 people share $1 / 2 \mathrm{lb}$ of chocolate equally?
