## MARINA OPERATORS LEGAL LIABILITY (MOLL)

Extends coverage for damage or loss to a customer's boats that is in the insured's care, custody and control.



## WATERCRAFT LIABILITY (P&I)

Liability arising out of the use, or ownership of vessels.



### SHIP REPAIRERS LEGAL LIABILITY (SRLL)

Provides care, custody and control for damage to vessels under repair or alteration by the insured



#### **OWNED VESSELS**

Property coverage for owned vessels.



### MISCELLANEOUS PROPERTY

Property coverage for forklifts, tractors, etc



#### **STACK STORAGE**

Property and MOLL coverage for stack storage facilities.



#### **COVERED SLIPS**

Property coverage for covered boat docks.



#### **UNCOVERED SLIPS**

Property coverage for uncovered docks, piers and wharfs."



#### **BUSINESS INTERRUPTION**

Covers the loss of income that a business suffers after a covered cause of loss.



#### **EMPLOYEE TOOLS**

Extends coverage for employee tools and equipment while off premises and removes theft exclusion
